### GENERAL COURSE OUTLINE

**Suggested Prerequisites:** A valid Texas Department of Licensing and Regulation license and a high school diploma or GED.

**Course Level:** Introductory

**Course Description:** An overview of the skills and knowledge necessary for the field of instruction of cosmetology students.

**End-Of-Course Outcomes:** Identify the laws and rules of the state licensing agency; explain teaching methodologies and lesson plan development. Upon completion of this course, the student will:

- Possess knowledge of the rules and regulations of South Plains College, this department and the state.
- Demonstrate teaching methodologies.
- Identify major points in lesson plan development.
